Aboriginal Access Fee Waiver:

Invoices & Payment Plans:

Application Fee: \$440 (inc GST) (non-refundable)

This fee is non-refundable and must be paid prior to the Application Closing Date for your course. You will not be able to commence training until we have receipt of your Application Fee.

Tuition Fee (GST Free)

- The Tuition Fee (where applicable) is invoiced 1 week after the commencement of the course.
- Payment due dates are stated in your initial invoice, due months 1, 4, 7 & 12.
- Each payment must be paid within 14 days, as stated in the initial invoice.
- Payments can be made via credit card or EFTPOS.
